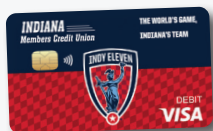

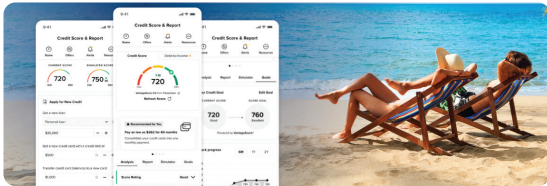

Three members will be elected to serve a three-year term on the Board of Directors. One member will be elected to serve on the Supervisory Committee for a three-year term. The Nomination Committee will review all applications and submit a slate of candidates to the Board of Directors. Interested members should follow the instructions at IMCU.COM to submit an application.

The deadline to submit applications is **August 10, 2026**. Volunteers are expected to:

- Attend monthly meetings
- Be willing to serve on subcommittees
- Accept the fiduciary responsibility that is required by service as a board member
- Interact with members in determining membership needs
