

Indiana Members Credit Union ‘Tis the Season to Win 2021 Sweepstakes Rules

Official Rules – Indiana Members Credit Union “IMCU ‘Tis the Season to Win 2021 Sweepstakes” November 15, 2021 – December 31, 2021.

NO PURCHASE NECESSARY TO ENTER OR WIN. USE OF INDIANA MEMBERS CREDIT UNION PRODUCTS AND SERVICES WILL NOT ENHANCE CHANCES OF WINNING A PRIZE.

1. **ELIGIBILITY:** The Indiana Members Credit Union “**IMCU ‘Tis the Season to Win 2021 Sweepstakes**” is offered and open only to legal residents who work or reside in Indiana Members Credit Union’s service territory: Bartholomew, Blackford, Boone, Brown, Clark, Clay, Clinton, Decatur, Delaware, Floyd, Fountain, Gibson, Grant, Hamilton, Hancock, Hendricks, Henry, Howard, Huntington, Jackson, Jefferson, Jennings, Johnson, Madison, Marion, Miami, Monroe, Montgomery, Morgan, Owen, Posey, Putnam, Randolph (Jackson or Wayne Townships), Ripley, Rush, Scott, Shelby, Tippecanoe, Tipton, Vanderburgh, Vigo and Warrick counties in Indiana, and Henderson County in Kentucky and who are at least 18 (eighteen) years old at the time of entry (“Entrants”). By entering, you agree to follow these Indiana Members Credit Union “**IMCU ‘Tis the Season to Win 2021 Sweepstakes**” official rules (the "Official Rules"). No fee is required for entry. **VOID WHERE PROHIBITED.** Employees, directors, contractors, vendors, marketing and promotion agencies, family members or individuals living in the same household as employees of Indiana Members Credit Union (“Sponsor”) are not eligible to participate.

2. **CONTEST PERIOD:** The Sweepstakes Period begins on Monday, November 15, 2021, at 12:00 a.m. Eastern Time, and ends on Friday, December 31, 2021 at 11:59 p.m. Eastern Time (the “Sweepstakes Period”).

3. **HOW TO ACCESS AND ENTER:** For the Grand Prize: (1) Each time an online purchase is made by an IMCU member using their IMCU debit or credit card during the sweepstakes period, they will receive an entry automatically into the \$2,500 grand prize drawing. (2) Entries will also be accepted at <https://www.imcu.com/register-to-win> and included in the drawing. (3) OR members can mail a 4" x 6" card with the following information: your full name; your complete address; Valid email address (if you do not have an email address, print "no email address"); Valid telephone number; the words “IMCU ‘Tis the Season to Win 2021 Sweepstakes”; and your signature.

For the weekly prize: (1) Each time an online purchase is made by an IMCU member using their IMCU debit or credit card during the sweepstakes period, they will receive an entry automatically into that week’s \$250 drawing. (2) Entries will also be accepted at <https://www.imcu.com/register-to-win> and included in the drawing each week. (3) OR members can mail a 4" x 6" card with the following information: your full name; your complete address; Valid email address (if you do not have an email address, print "no email address"); Valid

telephone number; the words "IMCU 'Tis the Season to Win 2021 Sweepstakes"; and your signature and it will be applied to the weekly drawing in the week that it is received.

4. DRAWING/ODDS: Sponsor will hold a random drawing from the pool of eligible entries for the \$2,500 grand prize and weekly for the \$250 weekly prize. Odds of winning will depend on the number of eligible entries received. In the event of a dispute as to the identity of a winner, the Sponsor's decision will be final. Winner will be required to respond (as directed) within twenty-four (24) hours of an attempted notification prior to being awarded a prize. Failure to respond to the notification within this timeframe may result in forfeiture of the prize. The drawings for the \$250 Gift Cards will be held on the following dates: Monday, November 22, 2021 at 9:00 a.m. Eastern Time, Monday, November 29, 2021, Monday, December 6, 2021 at 9:00 a.m. Eastern Time, Monday, December 13, 2021 at 9:00 a.m. Eastern Time, Monday, December 20, 2021 at 9:00 a.m. Eastern Time, Monday, December 27, 2021 at 9:00 a.m. Eastern Time, Monday, January 3, 2022 and the \$2,500 Gift Card grand prize will be pulled on Monday, January 4, 2022.

Sponsor reserves the right to substitute any prize with any alternate prize of equal or greater value at its discretion. Gift Cards are not redeemable for cash. Limit one prize per winner throughout the Sweepstakes Period.

All prizes must be picked up at Indiana Members Credit Union's Southside Branch, 5047 Madison Ave., Indianapolis, IN 46227, by 1:00 pm on Saturday, January 29, 2022 or it will be forfeited.

Sponsor is not responsible for lost, stolen, damaged, mutilated, returned, "bounced back" emails or misdirected mail, or unsafe arrival of a prize.

If the prize notification is returned as non-deliverable, or if winner is found to be ineligible or not to be in compliance with these Official Rules, winner may be disqualified and an alternate winner will be selected.

The prize winner is solely responsible for all applicable federal, state and local taxes and any expenses associated with the Sweepstakes, unless otherwise indicated.
