

# **Indiana Members Credit Union ‘Tis the Season to Win 2022 Sweepstakes Rules**

**Official Rules – Indiana Members Credit Union “IMCU ‘Tis the Season to Win 2022 Sweepstakes” November 14, 2022 – December 20, 2022.**

NO PURCHASE NECESSARY TO ENTER OR WIN. USE OF INDIANA MEMBERS CREDIT UNION PRODUCTS AND SERVICES WILL NOT ENHANCE CHANCES OF WINNING A PRIZE.

1. **ELIGIBILITY:** The Indiana Members Credit Union “**IMCU ‘Tis the Season to Win 2022 Sweepstakes**” is offered and open only to legal residents who work or reside in Indiana Members Credit Union’s service territory: Bartholomew, Blackford, Boone, Brown, Clark, Clay, Clinton, Decatur, Delaware, Floyd, Fountain, Gibson, Grant, Hamilton, Hancock, Hendricks, Henry, Howard, Huntington, Jackson, Jefferson, Jennings, Johnson, Madison, Marion, Miami, Monroe, Montgomery, Morgan, Owen, Posey, Putnam, Randolph (Jackson or Wayne Townships), Ripley, Rush, Scott, Shelby, Tippecanoe, Tipton, Vanderburgh, Vigo and Warrick counties in Indiana, and Henderson County in Kentucky and who are at least 18 (eighteen) years old at the time of entry (“Entrants”). By entering, you agree to follow these Indiana Members Credit Union “**IMCU ‘Tis the Season to Win 2022 Sweepstakes**” official rules (the "Official Rules"). No fee is required for entry. **VOID WHERE PROHIBITED.** Employees, directors, contractors, vendors, marketing and promotion agencies, family members or individuals living in the same household as employees of Indiana Members Credit Union (“Sponsor”) are not eligible to participate.

2. **CONTEST PERIOD:** The Sweepstakes Period begins on Monday, November 14, 2022, at 12:00 a.m. Eastern Time, and ends on Tuesday, December 20, 2022 at 11:59 p.m. Eastern Time (the “Sweepstakes Period”).

3. **HOW TO ACCESS AND ENTER:** Each time an online purchase is made by a participant during the sweepstakes period, an entry will be automatically received and entered into the drawing. Entries will also be accepted at <https://www.imcu.com/register-to-win> and included in the drawing.

4. **DRAWING/ODDS:** Sponsor will hold a random drawing from the pool of eligible entries. The drawings for all the gift cards will take place on Wednesday, December 21, 2022. Odds of winning will depend on the number of eligible entries received. In the event of a dispute as to the identity of a winner, the Sponsor’s decision will be final. Winner will be required to respond (as directed) within twenty-four (24) hours of an attempted notification prior to being awarded a prize. Failure to respond to the notification within this timeframe may result in forfeiture of the prize. Sponsor, in its sole discretion, may attempt to contact up to three (3) potential winners of a prize with the above procedure after which the prize in question may go un-awarded if it remains unclaimed.

5. PRIZES: Four (4) \$250 IMCU MasterCard® Gift Cards will be awarded, and one (1) grand prize \$2,500 MasterCard® Gift Card will be awarded to the grand prize winner. The total value of all prizes combined is \$3,500.

Sponsor reserves the right to substitute any prize with any alternate prize of equal or greater value at its discretion. Gift Cards are not redeemable for cash. Limit one prize per winner throughout the Sweepstakes Period.

All prizes must be picked up at Indiana Members Credit Union's Southside Branch, 5047 Madison Ave., Indianapolis, IN 46227, by 1:00 pm on Saturday, January 7, 2023 or it will be forfeited.

Sponsor is not responsible for lost, stolen, damaged, mutilated, returned, "bounced back" emails or misdirected mail, or unsafe arrival of a prize.

If the prize notification is returned as non-deliverable, or if winner is found to be ineligible or not to be in compliance with these Official Rules, winner may be disqualified and an alternate winner will be selected.

The prize winner is solely responsible for all applicable federal, state and local taxes and any expenses associated with the Sweepstakes, unless otherwise indicated.

6. GENERAL CONDITIONS: By entering in the Sweepstakes, unless you opt out, you authorize Sponsor to use, without further notification to you, review or approval by you, your name if you become a winner, to publicize the Sweepstakes and inform other Entrants of your winning. Each entry submission must be manually key stroked and manually entered by the individual Entrant; automated and/or repetitive electronic submission of entries (including but not limited to entries made using any script, macro, bot or Contest service) will be disqualified and transmissions from these or related email or IP addresses may be blocked. The accumulation of entries generated through robotic, automatic, macro, or like methods is also strictly prohibited. Sponsor's determination of whether a user is accumulating entries generated through automated means is in Sponsor's sole discretion.

If the Sweepstakes is terminated due to tampering or technical difficulties prior to its expiration date, notice will be posted at Indiana Members Credit Union's Facebook page and on Twitter and Instagram.
