Indiana Members Credit Union 'Tis the Season to Win 2022 Sweepstakes Rules

Official Rules – Indiana Members Credit Union "IMCU 'Tis the Season to Win 2022 Sweepstakes" November 14, 2022 – December 20, 2022.

Odds of winning will depend on the number of eligible entries received. In the event of a dispute as to the identity of a winner, the Sponsor's decision will be final.
