Home buyers or sellers are not eligible for Rewards if they use an agent outside this network. Using Indiana Members Credit Union for a mortgage is not a requirement to earn Rewards. Rewards amounts are dependent on the commissions paid to the agent. Indiana Members Credit Union may have specific rules on how your Rewards will be paid out. Rewards incentives are available in most states; however, are void where prohibited by law or by the lender. Please consult with your credit union to get details that may affect you.

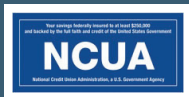

Members who obtain an FHA loan are required to receive their HomeAdvantage rewards at closing.
