

## **Indiana Members Credit Union 2026 Spring Mill Road Branch Open House Indy Eleven Prize Pack Sweepstakes Rules**

**Official Rules – Indiana Members Credit Union “IMCU 2026 Spring Mill Road Branch Open House Indy Eleven Prize Pack Sweepstakes” Saturday, May 2, 2026.**

**NO PURCHASE NECESSARY TO ENTER OR WIN. USE OF INDIANA MEMBERS CREDIT UNION PRODUCTS AND SERVICES WILL NOT ENHANCE CHANCES OF WINNING A PRIZE.**

1. **ELIGIBILITY:** The Indiana Members Credit Union “**IMCU 2026 Spring Mill Road Branch Open House Indy Eleven Prize Pack Sweepstakes**” is offered and open only to legal residents who work or reside in Indiana Members Credit Union’s service territory: Bartholomew, Blackford, Boone, Brown, Clark, Clay, Clinton, Crawford, Daviess, Decatur, Delaware, Dubois, Floyd, Fountain, Gibson, Grant, Greene, Hamilton, Hancock, Harrison, Hendricks, Henry, Howard, Huntington, Jackson, Jay, Jefferson, Jennings, Johnson, Knox, Lawrence, Madison, Marion, Miami, Monroe, Montgomery, Morgan, Owen, Parke, Perry, Posey, Putnam, Randolph (Jackson or Wayne Townships), Ripley, Rush, Scott, Shelby, Spencer, Tippecanoe, Tipton, Vanderburgh, Vigo, Warrick, Washington and Wayne counties in Indiana, and Breckinridge, Bullitt, Daviess, Grayson, Hancock, Hardin, Henderson, Henry, Jefferson, Larue, Marion, McLean, Meade, Nelson, Ohio, Oldham, Shelby, Spencer, Trimble, Union, Washington, and Webster Counties in Kentucky and who are at least 18 (eighteen) years old at the time of entry (“Entrants”). By entering, you agree to follow these Indiana Members Credit Union “**IMCU 2026 Spring Mill Road Branch Open House Indy Eleven Prize Pack Sweepstakes**” official rules (the "Official Rules"). No fee is required for entry. **VOID WHERE PROHIBITED.** Employees, directors, contractors, vendors, marketing and promotion agencies, family members or individuals living in the same household as employees of Indiana Members Credit Union (“Sponsor”) are not eligible to participate.

2. **SWEEPSTAKES PERIOD:** The Sweepstakes Period begins on Saturday, May 2, 2026, at 12:01 a.m. Eastern Time, and ends on Saturday, May 2, 2026, at 1:00 p.m. Eastern Time (“the Sweepstakes Period”).

3. **HOW TO ACCESS AND ENTER:** (1) Scan the QR Code on the enter to win poster at IMCU’s Spring Mill Road Branch, 17475 Spring Mill Road, Westfield, IN 46074, and fill out and submit the electronic form. (2) OR mail a 4" x 6" card with the following information: your full name; your complete address; Valid email address (if you do not have an email address, print "no email address"); Valid telephone number; the words “IMCU Spring Mill Road Branch Open House Indianapolis Zoo Tickets Sweepstakes”; and your signature.

Limit one entry per person, regardless of entry method used.

4. **DRAWING/ODDS:** Sponsor will hold a random drawing from the pool of eligible entries. The drawings will be held on Saturday, May 2, 2026. Odds of winning will depend on the number of

eligible entries received. In the event of a dispute as to the identity of a winner, the Sponsor's decision will be final. Winners will be notified via phone or email, on record for their account.

5. PRIZES: One (1) winner will be selected in a random drawing described above. The winner will receive four (4) Tickets to an Indy Elven Home Game for the 2026 season, game To Be Determined, valued at \$120, one (1) Parking Pass valued at \$20, and one (1) Autographed Indy Eleven Soccer Ball valued at \$100. The total value of all prizes combined is \$240.

Sponsor reserves the right to substitute any prize with any alternate prize of equal or greater value at its discretion. Gift cards are not redeemable for cash. Limit one prize per winner throughout the Sweepstakes Period.

The prize must be picked up at the Indiana Members Credit Union Spring Mill Road Branch, located at 17475 Spring Mill Road, Westfield, IN 46074, by 5:00 pm EST on Friday, May 22, 2026, or they will be forfeited.

Sponsor is not responsible for lost, stolen, damaged, mutilated, returned, "bounced back" emails, or misdirected mail, or unsafe arrival of a prize.

If the prize notification is returned as non-deliverable, or if winner is found to be ineligible or not to be in compliance with these Official Rules, winner may be disqualified and an alternate winner will be selected.

The prize winner is solely responsible for all applicable federal, state and local taxes and any expenses associated with the Sweepstakes, unless otherwise indicated.
