

# **Indiana Members Credit Union 2021 International Credit Union Day Sweepstakes Rules**

**Official Rules – Indiana Members Credit Union “IMCU 2021 International Credit Union Day Sweepstakes” Thursday, October 21, 2021 – Saturday, October 23, 2021.**

**NO PURCHASE NECESSARY TO ENTER OR WIN. USE OF INDIANA MEMBERS CREDIT UNION PRODUCTS AND SERVICES WILL NOT ENHANCE CHANCES OF WINNING A PRIZE.**

1. **ELIGIBILITY:** The Indiana Members Credit Union “**IMCU 2021 International Credit Union Day Sweepstakes**” is offered and open only to legal residents who work or reside in Indiana Members Credit Union’s service territory: Bartholomew, Blackford, Boone, Brown, Clark, Clay, Clinton, Decatur, Delaware, Floyd, Fountain, Gibson, Grant, Hamilton, Hancock, Hendricks, Henry, Howard, Huntington, Jackson, Jefferson, Jennings, Johnson, Madison, Marion, Miami, Monroe, Montgomery, Morgan, Owen, Posey, Putnam, Randolph (Jackson or Wayne Townships), Ripley, Rush, Scott, Shelby, Tippecanoe, Tipton, Vanderburgh, Vigo and Warrick counties in Indiana, and Henderson County in Kentucky and who are at least 18 (eighteen) years old at the time of entry (“Entrants”). By entering, you agree to follow these Indiana Members Credit Union “**IMCU 2021 International Credit Union Day Sweepstakes**” official rules (the "Official Rules"). No fee is required for entry. **VOID WHERE PROHIBITED.** Employees, directors, contractors, vendors, marketing and promotion agencies, family members or individuals living in the same household as employees of Indiana Members Credit Union (“Sponsor”) are not eligible to participate.

2. **SWEEPSTAKES PERIOD:** The Sweepstakes Period begins on Thursday, October 21, 2021 at 12:01 a.m. Eastern Time, and ends on Saturday, October 23, 2021 at 11:59 p.m. Eastern Time (the Sweepstakes Period”).

3. **HOW TO ACCESS AND ENTER:** (1) Scan the QR code at any IMCU branch or click on the link provided online at IMCU.COM and complete an entry. (2) OR mail a 4" x 6" card with the following information: your full name; your complete address; Valid email address (if you do not have an email address, print "no email address"); Valid telephone number; the words “IMCU 2021 International Credit Union Day Sweepstakes”; and your signature.

Limit one entry per person, regardless of entry method used.

4. **DRAWING/ODDS:** Sponsor will hold a random drawing from the pool of eligible entries. The drawings will be held on Monday, October 25, 2021. Odds of winning will depend on the number of eligible entries received. In the event of a dispute as to the identity of a winner, the Sponsor’s decision will be final. Winners will be notified via phone or email, on record for their account.

5. **PRIZES:** Thirty-two (32) winners will be selected in random drawings. Thirty-two (32) \$25 IMCU MasterCard® Gift Cards will be awarded to winners, one per branch. One (1) grand prize

winner will be selected in a random drawing, comprised of all entries from all branches. One (1) grand prize winner will be awarded a \$250 IMCU MasterCard® Gift Card. The total value of all prizes combined is \$1,050.00

Sponsor reserves the right to substitute any prize with any alternate prize of equal or greater value at its discretion. Gift cards are not redeemable for cash. Limit one prize per winner throughout the Sweepstakes Period.

The prize must be picked up at the Indiana Members Credit Union Southside Branch, located at 5047 Madison Ave. Indianapolis, Indiana by 5:00 pm EST on Friday, October 29, 2021 or they will be forfeited.

Sponsor is not responsible for lost, stolen, damaged, mutilated, returned, “bounced back” emails, or misdirected mail, or unsafe arrival of a prize.

If the prize notification is returned as non-deliverable, or if winner is found to be ineligible or not to be in compliance with these Official Rules, winner may be disqualified and an alternate winner will be selected.

The prize winner is solely responsible for all applicable federal, state and local taxes and any expenses associated with the Sweepstakes, unless otherwise indicated.

**6. GENERAL CONDITIONS:** By entering in the Sweepstakes, unless you opt out, you authorize Sponsor to use, without further notification to you, review or approval by you, your name if you become a winner, to publicize the Sweepstakes and inform other Entrants of your winning. For example, Sponsor may post on Indiana Members Credit Union’s Facebook wall, on Twitter, or other marketing channels a message such as: "Congratulations to our winners: John Doe, Mary Smith, etc.)!". If, in response to a notice of winning, a winner instructs, in writing, Sponsor not to publicize his or her name, Sponsor will honor that instruction.

Sponsor reserves the right, at its sole discretion, to disqualify any individual it finds, in its sole determination, to be tampering with the entry process or the operation of the Sweepstakes; to be acting in violation of these Official Rules; to be acting in a non-sportsmanlike or disruptive manner, or with intent to annoy, abuse, threaten or harass any other person.

Any use of robotic, automatic, macro, programmed or like entry methods will void all such entries by such methods and persons using any such methods will be disqualified. Each entry submission must be manually key stroked and manually entered by the individual Entrant; automated and/or repetitive electronic submission of entries (including but not limited to entries made using any script, macro, bot or Sweepstakes service) will be disqualified and transmissions from these or related email or IP addresses may be blocked. The accumulation of entries generated through robotic, automatic, macro, or like methods is also strictly prohibited. Sponsor's determination of whether a user is accumulating entries generated through automated means is in Sponsor's sole discretion.

Entries that contain offensive, harassing, threatening, abusive language or that violate the intellectual property or other proprietary right of any person are invalid and inadmissible.

If, for any reason, Sponsor is unable to run this Sweepstakes as planned due to infection by computer virus, bugs, tampering, unauthorized intervention, fraud, technical failures, or any other causes which, in the sole opinion of Sponsor, corrupt or affect the administration, security, fairness, integrity, or proper conduct of this Sweepstakes, Sponsor reserves the right to cancel, terminate, modify or suspend the Sweepstakes. If the Sweepstakes is terminated due to tampering or technical difficulties prior to its expiration date, notice will be posted at Indiana Members Credit Union's Facebook page and on Twitter.

**NOTICE:** Facebook and Twitter are in no way responsible for lost, stolen, misdirected, incomplete, misaddressed or ineligible entries. Facebook and Twitter are in no way sponsoring, endorsing, administering or associated with this Sweepstakes.

#### **7. RELEASE OF LIABILITY AND INDEMNIFICATION:**

By entering, each Entrant agrees to follow these Official Rules and forever releases, discharges, and waives any and all claims, liabilities and actions of any kind, howsoever caused or arising and whether by negligence, any intentional act or otherwise, that Entrant may have or that may arise against Facebook, Twitter, Sponsor, and each of their respective parents, subsidiaries, affiliates and related entities, as well as each of the aforementioned parties' respective directors, officers, owners, shareholders, members, employees, representatives, advertising or promotion agencies, successors, assigns and agents (collectively, the "Released Parties"), with respect to or arising out of either (i) Entrant's participation; or (ii) the receipt or use of the prizes (including but not limited to the substitution or changing of any prizing) awarded in the Sweepstakes. Each party to an action pursuant to this Section 8 shall be responsible for that party's costs of litigation to include but not be limited to attorney fees incurred by that party.
