Indiana Members Credit Union 'Tis the Season to Win 2023 Sweepstakes Rules

Official Rules – Indiana Members Credit Union "IMCU 'Tis the Season to Win 2023 Sweepstakes" November 6, 2023 – December 20, 2023.

NO PURCHASE NECESSARY TO ENTER OR WIN. USE OF INDIANA MEMBERS CREDIT UNION PRODUCTS AND SERVICES WILL NOT ENHANCE CHANCES OF WINNING A PRIZE.

1. 3. HOW TO ACCESS AND ENTER: Each time an online purchase is made by a participant during the sweepstakes period, an entry will be automatically received and entered into the drawing. Entries will also be accepted at <u>https://www.imcu.com/register-to-win</u> and included in the drawing.

4. DRAWING/ODDS: Sponsor will hold a random drawing from the pool of eligible entries. The drawings for all the gift cards will take place on Thursday, December 21, 2023. Odds of winning will depend on the number of eligible entries received. In the event of a dispute as to the identity of a winner, the Sponsor's decision will be final.
