

IMCU HomeAdvantage® Ring November Sweepstakes Rules

Official Rules – Indiana Members Credit Union “IMCU HomeAdvantage® Ring November Sweepstakes” Monday, November 1 – Tuesday, November 30, 2021.

NO PURCHASE NECESSARY TO ENTER OR WIN. USE OF INDIANA MEMBERS CREDIT UNION PRODUCTS AND SERVICES WILL NOT ENHANCE CHANCES OF WINNING A PRIZE.

1. ELIGIBILITY: The Indiana Members Credit Union “**IMCU HomeAdvantage® Ring November Sweepstakes**” is offered and open only to legal residents who work or reside in Indiana Members Credit Union’s service territory: Bartholomew, Blackford, Boone, Brown, Clark, Clay, Clinton, Decatur, Delaware, Floyd, Fountain, Gibson, Grant, Hamilton, Hancock, Hendricks, Henry, Howard, Huntington, Jackson, Jefferson, Jennings, Johnson, Madison, Marion, Miami, Monroe, Montgomery, Morgan, Owen, Posey, Putnam, Randolph (Jackson or Wayne Townships), Ripley, Rush, Scott, Shelby, Tippecanoe, Tipton, Vanderburgh, Vigo and Warrick counties in Indiana, and Henderson County in Kentucky and who are at least 18 (eighteen) years old at the time of entry (“Entrants”). By entering, you agree to follow these Indiana Members Credit Union “**IMCU HomeAdvantage® Ring November Sweepstakes**” official rules (the “Official Rules”). No fee is required for entry. **VOID WHERE PROHIBITED.** Employees, directors, contractors, vendors, marketing and promotion agencies, family members or individuals living in the same household as employees of Indiana Members Credit Union (“Sponsor”) are not eligible to participate.

2. CONTEST PERIOD: The Sweepstakes Period begins on Monday, November 1, 2021, at 12:00 a.m. Eastern Time, and ends on Tuesday, November 30, 2021 at 11:59 p.m. Eastern Time (the “Sweepstakes Period”).

3. HOW TO ACCESS AND ENTER: (1) Register for HomeAdvantage® via the <https://imcu.mycuhomeadvantage.com/> site during the Contest Period to be entered to win. Limit one (1) entry per person, per household and per email address for the entire promotion period. Only new registrations submitted during the Contest Period will be accepted. (2) OR mail a 4" x 6" card with the following information: your full name; your complete address; Valid email address (if you do not have an email address, print "no email address"); Valid telephone number; the words “IMCU HomeAdvantage® Ring November Sweepstakes”; and your signature.

4. DRAWING/ODDS: Sponsor will hold a random drawing from the pool of eligible entries. Odds of winning depend on the number of eligible entries received. One (1) winner will be determined from among all eligible entries received. Drawings to be conducted on or about December 1, 2021 by IMCU. In the event of a dispute as to the identity of a winner, the Sponsor’s decision will be final. Winner will be required to respond (as directed) within forty-eight (48) hours of an attempted notification. Failure to respond to the notification within this timeframe may result in forfeiture of the prize. Sponsor, in its sole discretion, may attempt to contact up to three (3) potential winners of a prize with the above procedure after which the prize in question may go un-awarded if it remains unclaimed.

Sponsor is not responsible for lost, stolen, damaged, mutilated, returned, "bounced back" emails or misdirected mail, or unsafe arrival of a prize. If the prize notification is returned as non-deliverable, or if winner is found to be ineligible or not to be in compliance with these Official Rules, winner may be disqualified and an alternate winner will be selected.
