

IMCU HomeAdvantage® Ring Sweepstakes Rules

**Official Rules – Indiana Members Credit Union “IMCU HomeAdvantage® Ring Sweepstakes”
June 1, 2021 – July 31, 2021**

NO PURCHASE NECESSARY TO ENTER OR WIN. USE OF INDIANA MEMBERS CREDIT UNION PRODUCTS AND SERVICES WILL NOT ENHANCE CHANCES OF WINNING A PRIZE.

1. **ELIGIBILITY:** The Indiana Members Credit Union “**IMCU HomeAdvantage® Ring Sweepstakes**” is offered and open only to legal residents who reside in Indiana Members Credit Union’s service territory: Bartholomew, Boone, Brown, Clinton, Decatur, Delaware, Floyd, Gibson, Grant, Hamilton, Hancock, Hendricks, Henry, Howard, Jackson, Jefferson, Jennings, Johnson, Madison, Marion, Monroe, Montgomery, Morgan, Posey, Putnam, Randolph (Jackson or Wayne Townships), Ripley, Rush, Scott, Shelby, Tippecanoe, Tipton, Vanderburgh, and Warrick counties in Indiana, and Henderson County in Kentucky, and who are at least 18 (eighteen) years old at the time of entry (each an “Entrant” and collectively the “Entrants”). By entering, you agree to follow these Indiana Members Credit Union “**IMCU HomeAdvantage® Ring Sweepstakes**” official rules (the "Official Rules"). No fee is required for entry. VOID WHERE PROHIBITED. Employees and family members (spouse, parents, siblings, and children) or individuals living in the same household as employees of Indiana Members Credit Union (“Sponsor”), and their respective parents, subsidiaries, affiliates, directors, contractors, vendors, marketing and promotion agencies, officers, owners, members, employees and agents are not eligible to participate.

2. **CONTEST PERIOD:** The Sweepstakes Period begins on Tuesday, June 1, 2021, at 12:00 a.m. Eastern Time, and ends on Saturday, July 31, 2021 at 11:59 p.m. Eastern Time (the “Sweepstakes Period”).

3. **HOW TO ACCESS AND ENTER:** Register for HomeAdvantage® via the <https://imcu.mycuhomeadvantage.com/> site during the Contest Period to be entered to win. Limit one (1) entry per person, per household and per email address for the entire promotion period. Only new registrations submitted during the Contest Period will be accepted.

4. **DRAWING/ODDS:** Sponsor will hold a random drawing from the pool of eligible entries. Odds of winning depend on the number of eligible entries received. Two (2) winners will be determined from among all eligible entries received. Drawings to be conducted on or about August 1, 2021 by IMCU. In the event of a dispute as to the identity of a winner, the Sponsor’s decision will be final. Winner will be required to respond (as directed) within forty-eight (48) hours of an attempted notification. Failure to respond to the notification within this timeframe may result in forfeiture of the prize. Sponsor, in its sole discretion, may attempt to contact up to three (3) potential winners of a prize with the above procedure after which the prize in question may go un-awarded if it remains unclaimed.

5. PRIZES: Two (2) Ring Doorbell with Echo Show 5, valued at \$149.98 each, will be awarded, according to the dates listed above in the Drawing/Odds section. The total value of all prizes combined is \$299.96.

Sponsor reserves the right to substitute any prize with any alternate prize of equal or greater value at its discretion. Limit one prize per winner throughout the Sweepstakes Period. All prizes must be picked up at Indiana Members Credit Union's Southside Branch, 5047 Madison Ave., Indianapolis, IN 46227, by 1:00 pm on Saturday, August 7, 2021 or it will be forfeited. Sponsor is not responsible for lost, stolen, damaged, mutilated, returned, "bounced back" emails or misdirected mail, or unsafe arrival of a prize. If the prize notification is returned as non-deliverable, or if winner is found to be ineligible or not to be in compliance with these Official Rules, winner may be disqualified and an alternate winner will be selected. The prize winner is solely responsible for all applicable federal, state and local taxes and any expenses associated with the Sweepstakes, unless otherwise indicated.

6. GENERAL CONDITIONS: By entering in the Sweepstakes, unless you opt out, you authorize Sponsor to use, without further notification to you, review or approval by you, your name if you become a winner, to publicize the Sweepstakes and inform other Entrants of your winning. Each entry submission must be manually key stroked and manually entered by the individual Entrant; automated and/or repetitive electronic submission of entries (including but not limited to entries made using any script, macro, bot or Contest service) will be disqualified and transmissions from these or related email or IP addresses may be blocked. The accumulation of entries generated through robotic, automatic, macro, or like methods is also strictly prohibited. Sponsor's determination of whether a user is accumulating entries generated through automated means is in Sponsor's sole discretion.

If, for any reason, Sponsor is unable to run this Sweepstakes as planned due to infection by computer virus, bugs, tampering, unauthorized intervention, fraud, technical failures, or any other causes which, in the sole opinion of Sponsor, corrupt or affect the administration, security, fairness, integrity, or proper conduct of this Sweepstakes, Sponsor reserves the right to cancel, terminate, modify or suspend the Sweepstakes. If the Sweepstakes is terminated due to tampering or technical difficulties prior to its expiration date, notice will be posted at Indiana Members Credit Union's Facebook page and on Twitter and Instagram.
