

Indiana Members Credit Union You Complete IMCU Chapstick Photo Sweepstakes

Official Rules – Indiana Members Credit Union You Complete IMCU Chapstick Photo Sweepstakes March 1, 2025 – March 31, 2025.

NO PURCHASE NECESSARY TO ENTER OR WIN. USE OF INDIANA MEMBERS CREDIT UNION PRODUCTS AND SERVICES WILL NOT ENHANCE CHANCES OF WINNING A PRIZE.

1. **ELIGIBILITY:** The Indiana Members Credit Union **“Indiana Members Credit Union You Complete IMCU Chapstick Photo Sweepstakes”** is offered and open only to legal residents who reside in Indiana Members Credit Union’s service territory: Bartholomew, Blackford, Boone, Brown, Clark, Clay, Clinton, Decatur, Delaware, Floyd, Fountain, Gibson, Grant, Greene, Hamilton, Hancock, Harrison, Hendricks, Henry, Howard, Huntington, Jackson, Jay, Jefferson, Jennings, Johnson, Lawrence, Madison, Marion, Miami, Monroe, Montgomery, Morgan, Owen, Parke, Posey, Putnam, Randolph (Jackson or Wayne Townships), Ripley, Rush, Scott, Shelby, Tippecanoe, Tipton, Vanderburgh, Vigo, Warrick, and Wayne counties in Indiana, and Henderson County in Kentucky and who are at least 18 (eighteen) years old at the time of entry (each an “Entrant” and collectively the “Entrants”). By entering, you agree to follow these Indiana Members Credit Union **“Indiana Members Credit Union You Complete IMCU Chapstick Photo Sweepstakes”** official rules (the "Official Rules"). No fee is required for entry. VOID WHERE PROHIBITED. Employees and, family members (spouse, parents, siblings, and children) or individuals living in the same household as employees of Indiana Members Credit Union (“Sponsor”), are not eligible to participate in this **“Indiana Members Credit Union You Complete IMCU Chapstick Photo Sweepstakes”**.

2. **Sweepstakes PERIOD:** The Sweepstakes Period begins on Saturday, March 1, 2025, at 9:00 a.m. Eastern Time, and ends on Monday, March 31, 2025 at 4:00 p.m. Eastern Time (the “Sweepstakes Period”).

3. **HOW TO ACCESS AND ENTER:** There are two ways to enter during the Sweepstakes Period:

VIA FACEBOOK: To enter via Facebook: (i) Visit any Indiana Members Credit Union Branch to get an IMCU Chapstick. Fill in the missing “I” in the Chapstick by decorating or designing in a creative way.; and (ii) After the entrant has decorated or designed an “I”, they must take a photo of the Chapstick and send it as a direct message to Indiana Members Credit Union’s Facebook page. To send IMCU a direct message on Facebook, visit the Indiana Members Credit Union page, select “Message”, and send a photo of your decorated/designed IMCU Chapstick. Entrant must have a Facebook account to participate in and enter this Sweepstakes via Facebook. Entrant must agree to comply with Facebook’s Statement of Rights and Responsibilities (<https://www.facebook.com/terms.php>) and Facebook’s Community

Standards (<https://www.facebook.com/communitystandards>) in order to create and maintain a Facebook account.

VIA INSTAGRAM: To enter via Instagram: (i) Follow @IndMembersCU on Instagram by going to <https://www.instagram.com/indmemberscu/> and clicking the “follow” button; (ii) Visit any Indiana Members Credit Union Branch to get an IMCU Chapstick. Fill in the missing “I” in the Chapstick by decorating or designing in a creative way.; and (iii) After the entrant has decorated or designed an “I”, they must take a photo of the Chapstick and send it as a direct message to Indiana Members Credit Union’s Instagram page. To send IMCU a direct message on Instagram, visit the Indiana Members Credit Union page, select “Message”, and send a photo of your decorated/designed IMCU Chapstick. Entrant must have a non-private Instagram account to participate in and enter this Sweepstakes via Instagram. If an Entrant does not have a non-private account, there is no cost to create one at <https://www.instagram.com/>. Entrant must agree to comply with the Instagram Terms of Use: <https://help.instagram.com/581066165581870>, Instagram’s Platform Policy: <https://www.instagram.com/about/legal/terms/api/>, and Instagram’s Community Guidelines: <https://help.instagram.com/477434105621119> in order to create and maintain an Instagram account.

Limit one entry per person, per entry method on social platform. Multiple entries per person, including multiple entries by the same Entrant using different social media accounts, will invalidate ALL entries submitted by that Entrant for the entire Entry Period. Entrants must direct message a photo of their designed IMCU Chapstick to @IndMembersCU on Instagram or the Indiana Members Credit Union Facebook page to be eligible to win. All entries must be received by Sponsor by Monday, March 31, 2025 at 4:00 p.m. Eastern Time. Due to the way Facebook and Instagram operate their services, Sponsor may not receive entries from Facebook and Instagram users with “protected” updates or profiles. For Entrants entering on Instagram, Entrants must continue to follow @IndMembersCU on Instagram through the Sweepstakes Period and for at least thirty (30) days thereafter (for potential notification purposes) to participate in the Sweepstakes and be eligible to win. For Entrants entering on Facebook, Entrants must continue to maintain an active Facebook account through the Sweepstakes Period and for at least thirty (30) days thereafter (for potential notification purposes) to participate in the Sweepstakes and be eligible to win.

All Instagram and Facebook posts must NOT, in the sole discretion of Sponsor, (i) contain language that violates or infringes upon another’s rights, including but not limited to privacy, publicity or intellectual property rights (including, without limitation, trademark or copyright infringement); (ii) contain language that is inappropriate, indecent, obscene, profane, hateful, tortious, defamatory, slanderous, controversial or libelous; (iii) contain language that promotes bigotry, racism, hatred or harm against any group or individual or promotes discrimination based on race, gender, religion, nationality, disability, sexual orientation or age; or (iv) contain language that is unlawful, in violation of or contrary to applicable laws or regulations.

4. DRAWING/ODDS: Sponsor will review direct messages and post options for voting on Instagram and Facebook on Thursday, April 3, 2025 at 11:00 a.m. Eastern Time and ask their Instagram and Facebook followers to comment which Chapstick design that is showcased in the

social media post is their favorite. Instagram and Facebook followers will have until Monday, April 7, 2025 at 11:59 p.m. Eastern Time to comment which is their favorite Chapstick design from the Top 4, the Chapstick design with the most votes is the winner. In the event of a dispute as to the identity of a winner, the Sponsor's decision will be final. Winner will be notified within twenty-four (24) hours of winning via the platform on which they submitted their entry (Facebook or Instagram). Winner will be required to respond (as directed) within twenty-four (24) hours of an attempted notification prior to being awarded a prize. Failure to respond to the notification within this timeframe may result in forfeiture of the prize. Sponsor, in its sole discretion, may attempt to contact up to three (3) potential winners of a prize with the above procedure after which the prize in question may go un-awarded if it remains unclaimed.

5. PRIZES: One (1) prize winner will be selected in the social media vote described above. The winner will receive one (1) Indiana Members Credit Union Mastercard® \$100 Gift Card (\$100 total prize value).

Sponsor reserves the right to substitute any prize with any alternate prize of equal or greater value at its discretion. Limit one prize per winner throughout the Sweepstakes Period.

The prize must be picked up at Indiana Members Credit Union's Southside Branch, 5047 Madison Ave., Indianapolis, IN 46227, by 4:00 pm on Friday, April 18, 2025 or it will be forfeited.

Sponsor is not responsible for lost, stolen, damaged, mutilated, returned, "bounced back" emails or misdirected mail, or unsafe arrival of a prize.

If the prize notification is returned as non-deliverable, or if winner is found to be ineligible or not to be in compliance with these Official Rules, winner may be disqualified and an alternate winner will be selected.

The prize winner is solely responsible for all applicable federal, state and local taxes and any expenses associated with the Sweepstakes, unless otherwise indicated.

6. GENERAL CONDITIONS: By entering in the Sweepstakes, unless you opt out, you authorize Sponsor to use, without further notification to you, review or approval by you, your name if you become a winner, to publicize the Sweepstakes and inform other Entrants of your winning. If, in response to a notice of winning, a winner instructs, in writing, Sponsor not to publicize his or her name, Sponsor will honor that instruction.

Sponsor reserves the right, at its sole discretion, to disqualify any individual it finds, in its sole determination, to be tampering with the entry process or the operation of the Sweepstakes; to be acting in violation of these Official Rules; to be acting in a non-sportsmanlike or disruptive manner, or with intent to annoy, abuse, threaten or harass any other person.

Any use of robotic, automatic, macro, programmed or like entry methods will void all such entries by such methods and persons using any such methods will be disqualified. Each entry submission must be manually key stroked and manually entered by the individual Entrant; automated and/or repetitive electronic submission of entries (including but not limited to entries made using any script, macro, bot or Sweepstakes service) will be disqualified and transmissions from these or related email or IP addresses may be blocked. The accumulation of entries generated through robotic, automatic, macro, or like methods is also strictly prohibited. Sponsor's determination of whether a user is accumulating entries generated through automated means is in Sponsor's sole discretion.

If, for any reason, Sponsor is unable to run this Sweepstakes as planned due to infection by computer virus, bugs, tampering, unauthorized intervention, fraud, technical failures, or any other causes which, in the sole opinion of Sponsor, corrupt or affect the administration, security, fairness, integrity, or proper conduct of this Sweepstakes, Sponsor reserves the right to cancel, terminate, modify or suspend the Sweepstakes. If the Sweepstakes is terminated due to tampering or technical difficulties prior to its expiration date, notice will be posted at Indiana Members Credit Union's Meta page and Instagram.

7. RELEASE OF LIABILITY AND INDEMNIFICATION:

By entering, each Entrant agrees to follow these Official Rules and forever releases, discharges, and waives any and all claims, liabilities and actions of any kind, howsoever caused or arising and whether by negligence, any intentional act or otherwise, that Entrant may have or that may arise against Meta, Instagram, Sponsor, and each of their respective parents, subsidiaries, affiliates and related entities, as well as each of the aforementioned parties' respective directors, officers, owners, shareholders, members, employees, representatives, advertising or promotion agencies, successors, assigns and agents (collectively, the "Released Parties"), with respect to or

arising out of either (i) Entrant's participation; or (ii) the receipt or use of the prize (including but not limited to the substitution or changing of any prizing) awarded in the Sweepstakes. All issues and questions concerning the construction, validity, interpretation and enforceability of these Official Rules, or the rights and obligations of participant(s) and Sponsor in connection with this Sweepstakes, shall be governed by and construed in accordance with, the laws of the State of Indiana, U.S.A., without giving effect to the conflict of laws rules thereof, and all proceedings shall take place exclusively in Marion County, Indiana. Each party to an action pursuant to this Section 8 shall be responsible for that party's costs of litigation to include but not be limited to attorney fees incurred by that party.
