## Indiana Members Credit Union Indiana Pacers Sweepstakes Official Rules

Official Rules – Indiana Members Credit Union "IMCU Indiana Pacers Sweepstakes" February 4, 2024 – March 2, 2024.

NO PURCHASE NECESSARY TO ENTER OR WIN. USE OF INDIANA MEMBERS CREDIT UNION PRODUCTS AND SERVICES WILL NOT ENHANCE CHANCES OF WINNING A PRIZE.

- 1. ELIGIBILITY: The Indiana Members Credit Union "IMCU Indiana Pacers Sweepstakes" (the "Indiana Pacers Sweepstakes" or "Sweepstakes") is offered and open only to legal residents who reside in Indiana Members Credit Union's service territory: Bartholomew, Blackford, Boone, Brown, Clark, Clay, Clinton, Decatur, Delaware, Floyd, Fountain, Gibson, Grant, Greene, Hamilton, Hancock, Harrison, Hendricks, Henry, Howard, Huntington, Jackson, Jay, Jefferson, Jennings, Johnson, Lawrence, Madison, Marion, Miami, Monroe, Montgomery, Morgan, Owen, Parke, Posey, Putnam, Randolph (Jackson or Wayne Townships), Ripley, Rush, Scott, Shelby, Tippecanoe, Tipton, Vanderburgh, Vigo, Warrick, and Wayne counties in Indiana, and Henderson County in Kentucky and who are at least 18 (eighteen) years old at the time of entry (each an "Entrant" and collectively the "Entrants"). By entering, you agree to follow these Indiana Members Credit Union "IMCU Indiana Pacers Sweepstakes" official rules (the "Official Rules"). No fee is required for entry. VOID WHERE PROHIBITED. Employees and, family members (spouse, parents, siblings, and children) or individuals living in the same household as employees of Indiana Members Credit Union ("Sponsor"), Pacers Basketball, LLC d/b/a Indiana Pacers and, Pacers Sports & Entertainment ("Pacers"), the National Basketball Association and its Member Teams, and NBA Properties, Inc. and each of their respective parents, subsidiaries, affiliates, directors, contractors, vendors, marketing and promotion agencies, officers, owners, members, employees and agents are not eligible to participate in this "IMCU Indiana" Pacers Sweepstakes".
- 2. SWEEPSTAKES PERIOD: The Sweepstakes Period begins on Sunday, February 4, 2024, at 12:00 a.m. Eastern Time, and ends on Saturday, March 2, 2024 at 11:59 p.m. Eastern Time (the "Sweepstakes Period").
- 3. HOW TO ACCESS AND ENTER: (1) February 4, 2024 through February 10, 2024, any new Indiana Members Credit Union deposit account opened (minor account that an eligible person opens on behalf of his or her minor child, checking account, savings account, certificate of deposit) will automatically receive an entry into the drawing. (2) February 11, 2024 through February 17, 2024, any new Indiana Members Credit Union auto loan opened will automatically receive an entry into the drawing. (3) February 18, 2024 through February 24, 2024, any new Indiana Members Credit Union credit card opened will automatically receive an entry into the drawing. (4) February 25, 2024 through March 2, 2024, all Indiana Members Credit Union Pacers Debit Card holders will automatically receive an entry into the drawing. Alternatively,

Any person is limited to 5 total entries, regardless of entry method used.

- 4. DRAWING/ODDS: Sponsor will hold a random drawing from the pool of eligible entries. The drawings for the prizes will take place on the following dates: Tuesday, February 13, 2024, Tuesday, February 20, 2024, Tuesday, February 27, 2024 and Tuesday, March 5, 2024. Odds of winning will depend on the number of eligible entries received. In the event of a dispute as to the identity of a winner, the Sponsor's decision will be final. Winner will be required to respond (as directed) within twenty-four (24) hours of an attempted notification via phone and/or email from information on their Indiana Members Credit Union member profile or from completed entry form on register to win site (located only at the link provided in Section 3 above) prior to being awarded a prize. Failure to respond to the notification within this timeframe may result in forfeiture of the prize. Sponsor, in its sole discretion, may attempt to contact up to three (3) potential winners of a prize with the above procedure after which the prize in question may go un-awarded if it remains unclaimed.

Each winner will receive one (1) autographed Tyrese Haliburton Indiana Pacers Jersey (\$130.00 value) and two (2) tickets to an Indiana Pacers home game on April 14, 2024 (\$99.00/ticket value; \$198.00 total prize value). The total value of all prizes combined is \$1,312. Retail value reflects unautographed merchandise. Retail value of hand signed merchandise is subject to fluctuation based on the featured player and current market value at the time of prize award.

Sponsor reserves the right to substitute any prize with any alternate prize of equal or greater value at its discretion. Jersey and tickets are not redeemable for cash. Limit one prize per winner throughout the Sweepstakes Period. Prize winner and his/her guest must agree to comply with all NBA venue rules and regulations relating to the use of NBA regular and post-season tickets (as applicable) and, in accordance therewith, agree not to act in an unsportsmanlike or disruptive manner, or with any intent to annoy, abuse, threaten or harass any other person at such game. Failure to do so may result in forfeiture of prize or prize element.
